## BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE MUNICIPAL LIBRARY DISTRICT OF MAPLEWOOD, MISSOURI, That the rate of taxation for the year 2023 is hereby fixed at

## GENERAL FUND

1.79 mills on each \$1.00, or seventeen and nine-tenths cents (.179) on each \$100.00 of the assessed valuation of all residential property made taxable by Law within the limits of the Municipal Library District of Maplewood for the General Fund for the maintenance of a free public library,

2.66 mills on each \$1.00, or twenty-six and six-tenths cents (.266) on each \$100.00 of the assessed valuation of all commercial property made taxable by Law within the limits of the Municipal Library District of Maplewood for the General Fund for the maintenance of a free public library,

3.02 mills on each \$1.00, or thirty and two-tenth cents (.302) on each \$100.00 of the assessed valuation of all personal property made taxable by Law within the limits of the Municipal Library District of Maplewood for the General Fund for the maintenance of a free public library,

## DEBT SERVICE

1.20 mills on each \$1.00, or twelve cents (.120) on each \$100.00 of the assessed valuation of all residential property made taxable by Law within the limits of the Municipal Library District of Maplewood for the Debt Service Fund of the library,

1.20 mills on each \$1.00, or twelve cents (.120) on each \$100.00 of the assessed valuation of all commercial property made taxable by Law within the limits of the Municipal Library District of Maplewood for the Debt Service Fund of the library,

1.20 mills on each \$1.00, or twelve cents (.120) on each \$100.00 of the assessed valuation of all personal property made taxable by Law within the limits of the Municipal Library District of Maplewood for the Debt Service Fund of the library,

If the tax rates allowed as determined by the State of Missouri are different than the proposed rates, the Library will set the rates at the rates determined by the State.
